The Panini Rural Municipality has allocated matching fund for Procurement of Solar Street Light Type-3 with Alternative Energy Promotion Center and the Rural Municipality intends to apply the fund to cover eligible payments under the Contract for supplying, providing and installation of Solar Street Light Type-3. Bid is open to all eligible Nepalese Bidders.
- 2. Interested eligible Suppliers may obtain further information and inspect the Sealed Quotation Forms at the Panini Rural Municipality Office of the Rural Municipal Executive Durgaphat Arghakhanchi.
- 3. Sealed Quotation Forms may be purchased on office time before 2076/09/04 by eligible Suppliers on the submission of a written application along with the copy of firm registration certificate, Tax clearance of F/Y 2074/75 or 2075/76 and upon payment of a non refundable fee of **Rs.1000.00**.
- 4. Sealed Quotations must be submitted to the above office on or before 12.00 noon on 2076/09/05. Quotations received after this deadline shall not be accepted.
- 5. Quotations must be valid for a period of **fifteen** days after opening of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to Nrs.**25000**(**Twenty five thousand only**) which shall be **valid for 75 days a**fter opening of the Sealed Quotations.
- 6. If Bidders wishes to submit the Cash Security, the Cash should be deposited in **Deposit Account No.056009051700509** at **Janata Bank Nepal Pvt.Ltd Pokharathok Arghakhanchi, Nepal** and submit the **original receipt** of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotations shall be opened in the presence of Supplier's representatives who choose to attend at 2:00 PM, 2076/09/05 at the Office of the Panini Rural Municipality Durgaphant Arghakhanchi.
